The expression of these views and positions are those of the author alone. They do not represent an official position of any governmental agency or administration. They are developed from a historical and scientific interpretation compilation of related reports. Till such time as they are supported by empirical observation, measurement, and testing, they remain reasoned speculation and formulated hypotheses.

As there is some indication of inter-subjective support, these views and hypotheses may be factoidal. Multiple remote viewers may provide intersubjective corroboration, but without empirical reality testing, hypnotic regression recollections or common myths may appear *factoidal*, but may not be scientifically confirmed facts. Following representative sampling, control-group testing of alternatives, and replicated convergent results, these common perspectives and operationalized hypotheses may be deemed to be facts that are consistent with some theories but not others. However, many observations for a variety of reasons are not readily amenable to such systematic analysis. Rare events, impact of inadvertent external events, cofactor confounding, and expenses of necessary experimental equipment can be challenging cofactors. When a hypothesis is found through scientific testing to be consistent with the data, it attains validity. Systematic testing of all plausible hypotheses, derived from a careful literature search of the subject, is necessary to discover which plausible hypotheses or theories are supported by the data and which are not. In this way, we proceed to obtain a sense of which theories appear to be lawful and which do not. An appreciation of the complexities of the process forces us to admit that there is much we may not know and there are limitations to what we think we know. These complexities reveal the difficulty of ascertaining the facts is such that many intelligent leaders avoid trying to deal with the subject. Meanwhile, interpretations of the findings presented are offered as an overture to stir public discussion, consideration, and understanding of matters bearing on the health and well-being of our relations with our galactic neighbors now as well as in our future. – continued on next page

My scientific empiricism predisposes me to demand replicable empirical evidence amenable to inter-subjective observation, measurement, and testing according to valid and reliable methods. This makes acceptance of assertions of reality of such E.T. entities rarely seen in public or on official media a challenge. Could these entities be drones or programmable robotic life-forms with cerebrally controlled artificial intelligence? Former governmental officials have admitted to launching counter-intelligence operations to confound possible adversaries by convincing individuals that what they had been observing were really E.T. visitors, in which case these entities might actually be terrestrial impersonators with born with physical mutations or deformities (e.g., Former OSI officer Richard C. Doty cited the Paul Bennewitz case as an example in which such deceptive activity may have been applied [27]).

- A UAP is an unidentified aerial phenomena that lands on and/or take off from the land on Earth or some other celestial body. (a.k.a. UFO)
- A USO is an unidentified submersible object. It may emerge from the sea or ocean or lake or river as well as dive into any of those bodies of water.

Nomenclature: What is a UAP (UFO) and/or USO?

More than one criterion can be necessary

Custom designed blimps or balloons could hover over a spot, appearing to manifest an anti-gravity levitation.

To avoid confounding inference, high-speed, right- or acute angle turns might be additionally necessary to be able to infer an off-world craft.

- 1 A UAP may be either or both of the above definitions, and be capable of high-speed, trans-medium travel, from the land to the water or *vice versa*.
- 2 These UAPs and/or USOs are capable of sudden acceleration and hypersonic speeds.
- 3 They may make right-angle or acute angle turns at high speeds.
- 4 They appear to have some sort of anti-gravity ionic drive or field propulsion; they have no airfoils, wings, or elevator surfaces required for conventional air travel. Potentially necessary, but not sufficient (for blimps could also appear to have no airfoils).
- 5 They may have cloaking, spoofing, and camouflaging (low visibility) capability [36].

The Johari Perceptual Window I

1955 Johari Window was formulated by Joseph Luft and Harry Ingraham

A masking (by donning a false-flag disguise) or a cloaking (activating an invisibility shield) can confound visual identification. Foresight may reside in the third quadrant. Classification limits information dissemination, which restricts the acceptance of knowledge to a selected few, may be necessary when pertaining to technology related to national security. We need to be aware of these limitations to popular acceptance of valid and reliable fact.

The Johari Perceptual Window II

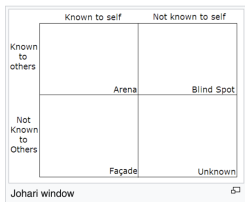


Figure 3: Joseph Luft and Harry Ingraham's Window

A brief excursion into exo-politics

- We have to consider aspects of history that are controversial if we are to ascertain the hidden driving forces to arrive at a plausible interpretation.
- In this presentation, we offer some points worthy of consideration, from which may emerge a more gentle, civilized, and sophisticated orientation to others.
- We don't have to accept all of these events as presented, but we should consider them for their authenticity, reality, and contribution to our development.
- Lessons from lost history are possible: We need to acknowledge, understand, and treat all sentient beings with respect, civility, compassion, and justice.

Ancient historical records suggest alien visitations have occurred for centuries

- The Mahabharata , written about 400 B.C.E. - 400 C. E., in India tells of Vimanas (flying cities or ships) that were used in wars and to carry gods hither and yon (Figure 4).
- The oral legends of the Navaho, Ute, and Hopi as well as petroglyphs & legends refer to the star people, from whom we came.
- Sumerian Cuneiform tablet writings refer to Annunaki as alien gods in ancient Mesopotamia.
- In the Bible, in the Book of Ezekiel, Ezekiel describes an experience of a visiting vehicle with wheels within wheels possibly suggesting some form of flying saucer.
- Mayan and Aztec artifacts revealed by the Mexican government exhibit space suits with artificial breathing apparatus and flying machines.
- At least one Renaissance painting depicts flying saucers over the Birth of St. Giovannini, as shown in the Figure below.

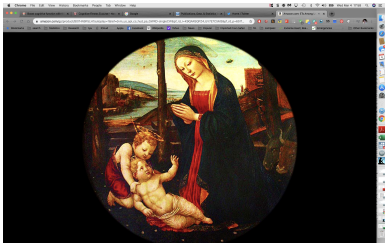

More Renaissance artistic evidence

- If the following painting is authentic, and not some objet d'art forged by counter-intelligence "Mirage Men" to divert the aficionados from the real truth, what are the implications for our visitations by extraterrestrials (ETs) [27].
- 1486 Carlo Crivelli painting of flying saucer beaming on woman in prayer (Fig. 6.)"The Annunciation, with St. Emidius" [1].



Nineteenth Century Evidence I

- 1 1884 June 6 John Ellis et al. (63 years before Roswell) in Max, Nebraska discovered a crashed craft, reported by the Nebraska State Journal 3 years later.
- 2 1897 April 17, Aurora, Texas E.T. vessel crashes into windmill on Judge Proctor's property and E.T. pilot dies and is given a proper burial in the local cemetery. Mr. Brawley Oats bought the property and buried the crash debris in a well. Oates developed arthritic tumor, that he suspected came from proximity or contact with the debris. Investigative journalist Jim Marrs reported this matter in his 2002 work, "The UFO Crash of 1897." [48]
- 3 Around the *Fin de siècle*, secret Prussian aircraft societies, inspired by Charles August Albert Dellschau, Carl Wilhelm Otto Lilienthal, and Gustav Freyer, based first in Texas and later in California (e.g., the Sonoro Aero Club about 130 miles East of San Francisco), were spotted by people and reported in some local papers as they tested new flying craft that crossed the North American Continent [39], [40].

Pre-World War II events

- 1 In 1932 Leo and Michael Dworshak living near Killdeer, North Dakota were reported by Timothy Good to have befriended visitors from a galaxy far away, who came to survey the Earth's environment [55, Part 1] .
- 2 1933 June 13, 14 years before the Roswell, N.M., USA incident, there was reported to have been a UFO crash in Magenta, Italy. David Charles writes this information was provided by the Vatican to the U.S. after the War and that the U.S. managed to acquire the partially intact vehicle. Benito Mussolini had set up a secret study group to reverse engineer the craft [60].
- 3 1936 Black Forest flying saucer crash in Germany. In 1936, a UFO crashed in the Black Forest of Germany. Hitler ordered a full scale investigation and the Nazi SS began reverse engineering the technology. This 1936 event led to work on SS research on Die Glöcke and the Haneubu flying saucers during World War II.

World War II developments I

- 1 Victor Schauberger's research was reported to have been incorporated into Nazi "Die Glöcke" (The Bell) vessel. Many of his assistants reportedly developed fatal health problems.
- 2 Nazi Haunebu models 1 through 4 were developed before the end of WWII, under the guidance of the SS and possibly Hans Kammler.
- 3 Hans Kammler (Dr. Walter Dornberger), who reportedly died in four different ways, was in charge of jet aircraft and vengeance weaponry for the Nazi SS but was at Bell Aircraft in the U.S..
- 4 General Eisenhower and Winston Churchill decided during WWII that the flying saucer technology needed to be kept secret for some span of time.
- 5 1941, Cape Girardeau, Missouri. UFO crash. Pastor Mann read the last rights for three small hairless aliens, whose bodies were buried 15 miles outside of town, according to the Pastor's family.

World War II developments II

- 6 1944-1945 Operation Paperclip, after finding that the Nazi nuclear program was a failure, provided amnesty and new identities for Nazi scientists who are willing to cooperate with the U.S. military in the need for advanced military technological development. The objective was to recruit these scientists and engineers before the Russians captured them [51, 13-19].
- 7 Hermann Oberth, brought to the U.S. under Operation Paperclip, admitted that the Nazis had ET help in developing their flying saucers.

Post-World War II Cold-War Review I

- 1 1946-1947 Operation High Jump, led by Admiral Richard Byrd officially to explore Antarctica, aborted the mission after the loss of men, vessels and helicopters in attack by Nazi Haunebu flying saucers emerging from their covert Antarctic base. Admiral Byrd was admonished to avoid discussion of the mission and its abortion. The covert purpose was to roust the Nazis from a base in *Neuswabenland*. Aircraft losses included two planes, two helicopters: and 4 aircraft lost, according to Peter Anderson, Office of Polar Programs, National Science Foundation, there were four aircraft lost in Operation High Jump.
- 2 June 24, 1947 pilot Kenneth Arnold, flying near Mt. Rainier, observed 9 flying saucers. Others observed those craft as well.
- 3 1947 July 3, there was a flying saucer crash at Corona, N.M. 75 miles away from Roswell, as well as the one on Matt Brazell's ranch near Roswell. He brought debris from the crash into authorities a day or two later.
- 4 1947 September 24 MJ-12 was placed in charge of the ET and flying saucer matters by Pres. Harry Truman. Top scientists, the CIA., and DIA, held an advisory role in MJ-12 supervision of the cosmic matters [41].

Post-World War II Cold-War Review II

- 5 1948 March Aztec, N.M. crash written up later by Frank Scully.
- 6 1950 March Farmington, N.M. sighting of saucer armada.
- 7 In 1951 US troops were disabled by UAPs during the Korean War. April 18, 1951 Private Francis P. Wall troops ordered villagers to evacuate and declared village as free-fire zone. A Saucer monitored this activity and then approached. Private Wall obtained permission to fire armor piercing bullets at the saucer. The saucer returned fire by irradiating the US troops with a pulsed burning beam that was invisible to all not targeted. The troops were weakened, and in three days they were disabled with dysentery, needing mobile evacuation [23, 126].
- 8 1952 July 19-20 and 26-27 Restricted airspace of Washington, D.C. was buzzed by fleet flying saucers. Radar confirmed that they were UAPs. Scrambled jets could not intercept them. USAF publicly attributed sightings to temperature inversions to avert public panic. Radar confirmations were publicly suppressed.
- 9 Project Bluebook was officially begun to investigate UFO sightings immediately after the buzzing of Washington, D.C. in 1952.

Post-World War II Cold-War Review III

- 10 1954 February 20-21 Eisenhower held secret rendezvous with E.T.s at Muroc (Holloman) AFB according to Art Campbell and Bill Kirkland at X-Conference in 2009. A Greed Agreement (The Omega Secret) [12]. was negotiated, according to which some Alien species were given secret residential status in return for assistance on matters of technology [2], [12].
- 11 1955 We (I and my 12 year old friend) observed what could have been a flying saucer in Glens Falls, N.Y. . We did not observe it perform any of Elizondo's observable criteria, apart from a silent hovering that could have been performed by a custom designed blimp to appear to be a flying saucer. There was a secret project to develop such blimps, as former CIA agent Mike Baker has reported on his *Black Files Declassified* Science Channel TV Series. The two pilots appeared to me to be human (from my view of their torso silhouettes, which was not close enough to clearly distinguish them from non-humans). Aware of the desire of US intelligence to keep these matters secret, I admonished my 12 year old friend that we should not publicly talk about it. I decided to release this information at the appropriate time. For more evidence that humans were flying these saucers, refer to Symmetry: A UFO Adventure by Preston Dennett and Dolly Safran for the testimony of Dolly Safran, who reported to have piloted one of the flying saucers [59]. Whether the pilots were secret U.S. test pilots flying a reversed-engineered craft, volunteer pilots such as Dolly described herself, or humanoid visitors surveying our military

culture, we owed them the presumption that without prior communication, explanation, and warning, they were non-hostile enemies not subject to weapons training, targeting, acquisition, and destruction. Ergo, I suggest that no military force should be barbarically trying to target or destroy these craft without adequate self-defensive justification.

The Vietnam War era I

- 1 During the Vietnam War, the code-word for flying saucers was "enemy helicopters," because the North Vietnam Army did not have helicopters.
- 2 On June 15, 1968, Lt. Pete Synder in swift boat PCF-12 on the Cua Viet river received a request for help from Commander Richard Davis whose PT boat was being attacked by two "enemy helicopters." Upon arriving on the scene, Snyder witnessed a blinding flash of light illuminate Davis PT boat whereupon it exploded killing all but two servicemen. Snyder filed a preliminary report and was ordered to continue his patrol. As two saucers approached the PT boat, Snyder requested air support. Attempts by the PT boat to fire upon the saucers had no effect. Two responding F-4 phantoms appeared to cause the saucers to depart [44]. The flying saucer attack on an allied Aussie destroyer followed with the identical shells fired at the saucer from the second PT boat [23], [44]. 78
- 3 1963-67. US Army Cmd. Sgt. Major Robert O. Dean (Fig.7), was seconded to NATO Supreme Headquarters Allied Powers Europe, where he learned of UFO overflying restricted NATO military airspace in February 1961 [49].

The Vietnam War era II

- ④ 1965 December 9, Kecksburg, Pa. Acorn shaped UAP crashes and retrieved by U.S. military.

Recent High Level Military Officers Writings and Statements I

- 1 1997 Philip J. Corso and William J. Birnes, The Day after Roswell, Pocket Books, Rosewood Rose Productions, Inc. was published, wrote of seeing the E.T. alien bodies [50, 17,33].
- 2 2002 January 14, Paintsville, Kentucky. A coal train collided with UFO hovering about 12 feet over the track, severely damaging the engine [35]. The UAP abruptly departed apparently unscathed.

- Within that book, he admitted catching a glance at the bodies, noting that the diminutive bodies were clearly non-human [50, 17,33].

- According to Stone, "We are about to begin to travel in space." We will soon be seen as aliens to denizens of other worlds, moons, or stars that we visit.
- Soon, we will be appear to be traveling in some else's UFOs.
- How would we want to be welcomed and treated? [22] [13].
- The one thing they teach us is that we are probably not alone. There is ample evidence that have been probably been visited for millennia.
- Whether in the Bible, history, or in current events, Ebens and human beings continue to teach us how important it is that we be as good as we can be to one another. Diversity is the norm. Tolerance and respect for it should be *de regèur*. We have to work within that milieu to render the world a better and more habitable place if it is to be preserved.

According to US Army Sergeant Clifford E. Stone, ret., who admitted serving as a member of top secret UFO crash retrieval team:

- Stone claimed to know of more than 57 species of visiting Ebers.
- He made this statement in public at the National Press Club in Washington, D.C. on December 9, 2001 that there are more than 57 species of Aliens that have visited Earth.
- He made the point that they are not hostile and pose no threat to our national security [13].
- As Commander David Fraver, flying an F-18-F "Super-hornet," said in checking out the tic-tac UFO on Nov. 14, 2004 that the UFO capabilities were beyond anything he was aware that we had. I would infer that if the tic-tac craft was hostile, his plane would not have fared so well. He was judiciously non-provocative. I would have recommended that he should have tried to communicate in a friendly way with the craft.

Former USAF weatherman: Charles J. Hall, Jr.

Testing the Extraterrestrial hypothesis

Tall White E.T.s reside on a secret part of the US Air Force Nellis Range in Nevada [2].

- According to Charles J.Hall, Jr. , in his series **Millenial Hospitality, Vols.1 through 5** there is non-human intelligence (Hall calls them "Tall Whites") residing as guests of the U.S.military on part of the Nellis AFB range [2].

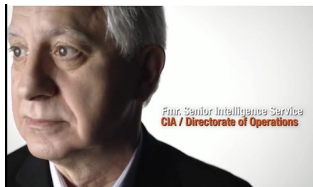
Figure 12: Photo of Eben reportedly provided by Boyd Bushman before his passing

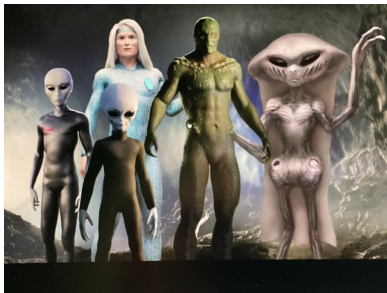


Figure 14: Five of the visiting E.T. species—specifically, a Grey, Eben, Nordic, Heplaloid, and a Trantaloid

David Adair

- David Adair, an researcher for the U.S. Defense Department, who advised J. Allen Hynek on Project Bluebook, mentioned Aquafarians, called Padians, as an E.T. visiting species [46].
- He also mentioned Silicon based E.T.s (not depicted here) [47].
- Adair noted that not all E.T. species are friendly. Some acted more like pirates. The unfriendly species were referred to as Hostile Alien Visitors.
- Linda Moulton Howe reported having been informed that some E.T. species have abducted humans and have reported under hypnotic regression being subjected to harvesting of RNA/DNA as well as genetic manipulation.
- The Government demanded lists of those taken but were dependent on E.T.s for cooperation;
- The Government was not able to control this activity, so it demanded that the humans not be harmed. To prevent psychological harm, memories of the medical testing were supposed to have been erased.
- The Government reportedly may have relented to allow some animal testing instead [6], [10].

David Adair spoke of this Aquafarian species, called Padians, among others



Randy Cramer, who claimed to have worked with the Secret Space Program, indicated that he had encountered an insectoid species in his work.

Draco Reptilians

- The existence of Draco-Reptilians was reported by Romanian General Emil Strainu.
- Reptilians or Heplaloids have vertical slits for pupils.
- Draco refers to having wings and being capable of flight as found in the Figure on page 47.
- They are reportedly imperialist conquerors who prefer others to do the fighting for them.
- Rumored to have been allied with Nazis and to have had a secret base in Antarctica, with whom Adm. Byrd had a run-in on Operation High Jump in Antarctica after WWII 1946-1947.

- The Heplaloid home is reported to be Planet Damco in the Cygna arm
- Reptilians or Lizard-like E.T.s were considered Heplaloids.

Archquloids were reported to have secretly meet President Eisenhower in February 20-21, of 1954

- Ike reportedly secretly meets with the Archquloids extra-terrestrials at Muroc (now Edwards) AFB on Feb 19-21, 1954 [9], [12]
- The Greada Agreement: Providing a secret base for the E.T.s in return for help with reverse engineering of their craft [9], [12], [16].
- These Archquloid extraterrestrials (ETs) has serpentine vertical pupils and pronounced proboscis.
- Nordics or Telosians offered technological help in return for unilateral nuclear disarmament.
- The Russians had just tested a nuclear bomb in 1949 so the nuclear arms race was launched. Hence, Eisenhower refused the offer.
- Figure 17 depicts the appearance of an Archquloid with his translator device.
- Figure 63 shows the Archquloid saucer landing at Muroc AFB.

Testing the Extraterrestrial hypothesis: Early US contactees were reportedly closely monitored by the Government I

- 1 They were contacted to help prepare the Earth for Galactic Status and the obsolescence of nuclear weapons and their ballistic delivery systems.
- 2 Multiple former military and government officials have acknowledged that Aliens exist and live among us, that we are not alone. Nor have we been alone. We have been visited for millennia. Among these leaders are former USAF Lt. Col. Wendelle C. Stevens, former CIA official Jim Semivan, former Cmd. Sgt. Major Robert O. Dean [2], [10], [25], [37].
- 3 We should be willing to acknowledge Charles J. Hall, jr.'s "Millennial hospitality."

Testing the Extraterrestrial hypothesis: Early US contactees were reportedly closely monitored by the Government II

- 4 George Van Tassel's annual conferences at Giant Rock became an annual festival reportedly attended by Federal agents. Van Tassel claimed ETs gave him the secret to preserve youth and he set about building the Integratron to assist this process but died before he could complete it.
- 5 George Adamsky was visited by Orthon who claimed to be a Venusian [32].
- 6 Orthon tried to suggest that the U.S. should not shoot at the saucers. This was not accepted at first by the U.S. government.

Testing the Extraterrestrial hypothesis: Early US contactees were reportedly closely monitored by the Government III

- 7 Val Thor also claimed to be from Venus and became a VIP consultant to the Eisenhower Administration for his three year visit [19, chap6].
- 8 Daniel Fry, Dan Sherman, and George Hunt Williamson were other contactees. Sherman bowed out when he learned about the abductions [10]
- 9 Howard Menger was one of Val Thor's contactees. Menger lived in High Bridge, N.J. [19, Chap6].
- 10 US counterintelligence was fearful that foreign powers could use leverages against the national interest for which reason the FBI, USAF-OSI, MJ-12, and the CIA monitored contactee activities [27].

Testing the Extraterrestrial hypothesis: Early US contactees were reportedly closely monitored by the Government IV

- 11 Extraterrestrial exposure Act authorized detention if they came into contact with an ET and if it was deemed to be of national interest [5], [27].
- 12 In Preston Dennett's book, Symmetry: A UFO adventure he writes that Dolly Safran, a brilliant woman who aspired to learn how to fly and to become a nurse, was taken aboard an E.T. flying saucer during her youth and awarded a scholarship in piloting the spacecraft. In Preston's fascinating book, Dolly recounts her adventures flying the saucer, her visits to other planets and star systems, as well as her helping others brought on board [59].

Testing the Extraterrestrial hypothesis: Prominent astronauts have indicated that we have been visited by Extraterrestrials

- 1 Gordon Cooper, one of seven US astronauts in Project Mercury, observed a flying saucer landing at Edwards AFB in 1957, had written to the United Nations about his having observed Alien craft far more capable than anything he knew about possessed by our military.
- 2 Dr. Edgar Mitchell, the sixth man to walk on the moon, believed that Alien visitation had been to explore our military development and to guide us onto a more peaceful path.
- 3 Buzz Aldrin had admitted to having seen Alien UFOs in space. He passed a lie detector test on the matter as well.
- 4 Pavel Popovich, a Russian Cosmonaut, commander of Vostok 4 and Soyuz 14, while flying home with a delegation of scientists, saw a triangular shaped UFO.
- 5 Donald Slayton, an American Astronaut, flying a P-51 mustang observed a flying saucer.

Testing the Extraterrestrial hypothesis: Other Early Non-U.S. contactees

- 1 Janus, a self-proclaimed E.T., contacted Prince Philip of the U.K..
- 2 Project Condign was the British UAP study by the Ministry of Defense.
- 3 Professor Hernandez was contacted by Elyense (Lya), an E.T. posing as a student, in Mexico 1972-74 admitted that she was from the Andromeda Galaxy [19, chap6].
- 4 Maurizio Cavallo was enticed by an E.T. named Suell, meet other E.T.s , according to Paola Harris, in Italy.
- 5 In Italy, in the Pescara region, near the Adriatic Sea, the Amicizia (friendship) society consisted of human looking ETs lived in underground bases. and were helped by amicable locals
- 6 Luis Fernando Mostajo, an architect from Bolivia, was another contactee who reported having been taken to Venus and a moon of Jupiter called Gannymeade, where he observed other alien civilizations alive and well. Fernando Mostajo also reported a submerged reserve of aliens residing in Lake TiticacaTitivateta, Mexico. If these reports are true, we have many more relations to explore [5].

Prominent Influencers, leaders, and authors

- 1 Steven M. Greer, M.D., author of *Unacknowledged: An Exposé* and *Sirius Disclosure*, argues that financial greed and excessive secrecy is retarding full UFO disclosure. Greer organized several symposia at the National Press Club where former government officials disclosed previously secret governmental activities relating to UAP investigations and coverups .
- 2 Nick Pope, former U.K. investigator of the U.K. Department of Defense UFO investigations focuses on the military applications of the technology as the reason for secrecy .
- 3 Luis Elizondo, former officer of U.S. Pentagon Advanced Aerospace Threat Identification Program resigned to do less constrained private UFO investigations.
- 4 Tom DeLonge, former Blink 182 musician and organizer of the Stars Academy with Steve Justice (former Lockheed-Martin Officer), Harold E. Putoff, Ph.D. (Director of Institute of Advanced Studies at Austin), and Jim Semivan (former CIA officer) to facilitate responsible UAP disclosure.
- 5 Chris Mellon, a former Deputy Assistant Secretary of Defense, was a former advisor to *To the Stars Academy*.
- 6 Preston Dennett, author of multiple books and *Mutual ufo network* investigator Dennett, Preston

ET communication was reportedly established I

- 1 A 3 minute message was beamed at Messier 13 by 24 scientists at Arecibo Observatory in Puerto Rico in the early 1970s [17].
- 2 Messier 13 is a cluster of 300,000 stars about 24,000 light years away.
- 3 Project Sigma permitted and developed communication with some ETs [17] [19] [18].
- 4 Project Plato reportedly pursued the diplomatic and scientific exchange program as Project Chrystal Night (also later known as Project Serpo [28].) [45].

ET communication was reportedly established II

- 5 There have been multiple claims of collaboration of Ebens and U.S. Government at Area 51 and Las Alamos—e.g., reports of Bob Lazar, David Adair, Capt. Bill Uhouse, Edgar Fouche, Richard C. Doty, and others. with regard to reverse engineering of Alien technology.
- 6 Project Chrystal Night or Project Serpo was cited as a diplomatic exchange program of scientists and engineers that was undertaken for cooperation, according to former USAFOSI official, Richard C. Doty [45]. . Len Kasten authored a book entitled, Secret Journey to Planet Serpo: A True Story of Interplanetary Travel.
- 7 Charles J. Hall, Jr. reported a telepathic communication link on his tour of duty on the Nellis Range with the "Tall Whites."

Preparations: Pre-eminent issues, protocols, and preparations for communication, collaboration, coordination, and cooperation

- 1 Establishment of a protocol for communication. The protocol entails learning a common language through which communication will take place. Most Ebens communicate via telepathy.
- 2 Provision of essential environmental resources : clean air, potable water, adequate food, fruit, and vegetables, nutrients, along with adequate facilities for sewage and waste removal.
- 3 Provision of adequate environmental requirement: tolerable temperature range, viral and bacteriological contamination.
- 4 Emergency provisions for decontamination and hospitalization to save and secure lives of sentient beings from danger of deficiency to any of the following.

- 1 Sources of efficient fuel may be needed. Provisions for these should be available.
- 2 Protection from threats to the foregoing from tornados, floods, extreme snow storms, deep freezes, or hurricanes, etc.
- 3 Issues of colony settlement, cross-cultural tutelage, travel, and acculturation would have to be addressed.
- 4 We should try to be kinder, compassionate, and more protective of the flora and fauna in our environment. We need to treat Cataceans with more decency. If Whales, dolphins, and other sentient creatures sharing our Earth do not threaten us, we should not needlessly hunt or hurt them.

The Greda Agreement Feb. 19-20, 1954 concluded with the Greys instead of the Pleiadians or Nordics

- 1 Notions of E.T. agendas surface in the negotiations and agreements with E.T.s.
- 2 Reported conditions of agreement: There would be a scientific exchange over a ten year period, later reported to have lasted for 1964-1978 [28], [?].
- 3 There would be an exchange advanced technology in return for secret bases.
- 4 Shower heads on bases would have two nozzles: One for water and one for enzymes, to be supplied by the Alien visitors [25]. These were setup at Area 51(S4), or at Las Alamos, according to Richard Doty.
- 5 They would bring their own food source, which we would have to learn to culture at Area 51 [25].
- 6 List of all abductees who would be returned to place of abduction without injury and without memory of the event.
- 7 Eisenhower reportedly did not believe we could effectively prevent the abductions and genetic experimentation so we relented.
- 8 It provided for secret bases for the Ebens on Government or Reservation land.

Treaty negotiations

- Because the Archquloids wanted nuclear disarmament in return for technological support, Eisenhower declined to accept their terms.
- The Treaty was signed with the Greys instead.
- Original papers of the treaty were reportedly kept at the Brookings Institute [19]. [16]

Treaty accords

- 1 Ebens could conduct experiments on abducted persons or twins as long as they would not be harmed. Ebens were supposed to provide a list of those who had been examined. We had no way to regulate this as it was completely beyond our capability to control.
- 2 Genetic experimentation to fortify species for space travel and to prevent Eben species from dying off.
- 3 Memories of the experiments and tests on the part of abductees would be erased.
- 4 The accords may have included animals (cattle or sheep) to test for effects of radiation contamination from areas where secret or underground tests had been performed.

Hypotheses about E.T. agendas I

- 1 To prevent global nuclear war, as evidenced by the works of Valiant Thor [43], Steven Greer [42], and Linda Moulton Howe [10], amongst others.
- 2 To preserve the environmental habitability of the planet [10].
- 3 To reduce economic resource scarcity and war.
- 4 Purpose of abductions: To genetically enhance the human species by genetic experimentation and hybridization for telepathy, space travel and radiation resistance [12], [10], and [43].

Hypotheses about E.T. agendas II

- 5 From the writings of Charles J. Hall, Jr., in Millenial Hospitality, Vols 1 through 5, it appears that in return for cooperation some species of E.T.s were provided with secret V.I.P. sanctuaries on military bases or testing ranges [2].
- 6 The Greys routinely engage in genetic experimentation and enhancement after death. They seem involved in developing hybrid offspring to possibly facilitate genome empowerment [10].
- 7 To monitor genetic experimentation over long time scales [10].
- 8 The animal mutilations seem to be part of the genetic experimentation program of the aliens, sometimes supervised by the insectoid species [10]
- 9 David Adair. in an interview by Emery Smith for Cosmic Disclosure, suggested that some E.T. species may more piratical activities and possibly involved in human trafficking [47].

Hypotheses about E.T. agendas III

- 10 Dr. Roger Leir, who passed away in 2014, had extracted alien implants from abductees and found them made of extraterrestrial materials. The implants were possible tracking devices.
- 11 Subsequent research by Dr. Stephen Colbern found that these implants may be used to track, monitor, and potentially influence humans.
- 12 They may want to teach man space law before he endeavors to engage in interplanetary colonization, interstellar mining, refining, commerce, environmental protection, and the pacific resolution of disputes before he begins polluting the galaxy and disturbing universal peace.
- 13 Linda Moulton Howe, an investigative journalist, reported that an abductee, Linda Porter, who was told that E.T. Greys facilitate the transfer of souls in reincarnation through rapid-cycle cloning [8].

Michael Sala's E.T. Intervention Typology

- 1 Type A: Extraterrestrials establish ground teams and Earth bases with members integrating into human society for monitoring and influencing humanity's evolution. Vital interests of individuals are respected.
- 2 Type B: Extraterrestrials physically contact individuals, share information, take individuals into their ships to witness advanced technologies, and/or take individuals to extraterrestrial bases or societies. Vital interests of individuals are respected.
- 3 Type C: type C: hands-off approach: esoteric telepathic communication & spiritual guidance.
- 4 Type D: Extraterrestrials establish technology exchange agreements with covert government entities and/or gain permission for genetic upgrade programs, and basing rights. Vital interests of individuals are NOT respected. [5, 95].

Findings regarding the E.T. hypothesis

- 1 Former high level governmental officials claim that it is true—e.g., Paul Hellyer, Philip J. Corso, Richard C. Doty, Robert O. Dean, among others.
- 2 Former Astronauts support this hypothesis. Dr. Edgar Mitchell and Gordon Cooper are prominent examples.
- 3 They support the notion that 5 or more species have visited Earth.
- 4 Commonplace in the stories of abductees was missing time, during which they recall (often under hypnosis) to have been abducted.
- 5 Abductee stories and the discovery of implants by surgeon Dr. Roger K. Leir's in their bodies was revealed his 1998 book, The Aliens and the Scalpel [53].

Lyrans from Pleiades

- Reported to come from the ring nebula of Lyra
- Lyrans are our oldest ancestors, keepers of the Galactic history of Earthlings [19].
- Pleiadians are descendants of the Lyrans
- large black almond eyes
- have fought battles with Greys in past and warned Billy Meier about their lack of empathy & wisdom in dealing with Earthlings
- type B intervention protocol with personal interaction, giving rides on craft, and warnings about negative E.T. species.
- Primary mission is to warn Earth about negative ET species: e.g., Greys with whom they had wars in past.

Despite the UFO ... Contact from Semjase, the Pleiadians were the first to warn Earth about the danger that Grey aliens posed. The Pleiadians accused the Greys of having a lack of wisdom and empathy when using technologically inferior humans to serve their evil, remorseless purposes.

Semjase, a Pleiadian, allowed herself and friends to be photographed while visiting Billy Meier at his home in Switzerland

Investigated by USAF Lt. Col. Wendelle C. Stevens and no evidence of fraud was found.

- Pleiadians reportedly were descendants of the Lyrans
- the Pleiades star cluster is about 440 light-years from Earth
- Semjase assured Billy that he would be their representative on Earth.:
- that they came from Taygeta with main planet Erra [19].

We are neither guardians of Earth nor beings of God-sent angels or similar. Many persons suggest we are watching over Earth and her beings and would control their fates. This is not true because we only perform a self-selected mission which has nothing to do with supervising or regulating Earth's fate. Thus it is wrong to expose us as superterrestrial messengers and guardians.

- Lt. Col. Wendell Stevens visited Billy Meier and had his photos and other material tested. According to Lt. Col. Stevens, no evidence of fraud or fabrication was found in the reportage of these visitations (Stevens, Lt. Col. W. C., UFO ... Contacts from the Pleiades - Vols 1 & 2).

Semjase

- Semjase was reported to have been identified as Maria Orsic, the Vrili society leader, who allegedly channelled the "beamship" blue-prints to the Nazi SS.]
- More current reports indicate the Pleiadians were trying to help mankind find freedom through education and consciousness raising from oppressive social structures.
- More recent Interaction with the Pleiadians seems overwhelmingly positive.
- SemJase seemed to maintain that they Greys were taking advantage of us.

Vegans

- Some, like the Arcturians (see picture on page 84), have blue skin, just like the Goddess Vishnu.
- In The book of Enoch, intermarriage between the Nephilim and humans and produced a race of giants that eventually died off [19].
- In a parallelism, Billy Meier mentions genetic experimentation between Lyrans and Vegans and humans produced a race of hybrid human –animals that eventually died off [19]

Quadloids

- Putatively carnivores.
- Linda Moulton Howe claims she read that Quadloids were cloned by Ebens from humanoid lizards and praying Mantis aliens [6], [7].
- Some are reptilian in appearance and reported to live in subterranean tunnel systems.
- Very intelligent and wise ETs according to Preston Dennett [20].
- Mantis insectoid (shapeshifters) Ebens.
- reportedly created by Ebens From Planet Otto in the Zeta Reticuli (approx. 39.5 light years from Earth) system

Trantaloids

- potentially hostile alien visitor (HAV) from Planet Silas in the Zeta-Reticuli system
- home is 10.5 light-years away in the third planet from Epsilon Eridani in the constellation Eridanus
- an insectoid species.
- suspected of performing experiments on humans
- reputed to cross-breed with humans
- may be responsible for some cattle mutilations
- reportedly capable of appearing human (from Briefing of Ronald Reagan by DCI William Casey and others on E.T. presence on Earth)
- reportedly potentially dangerous to humans [7].

Some Ebens remain aloof and others have been attacked by panicked local people

- Other Ebens, who remain aloof from humans, due to human tribalistic, ethnocentric, xenophobic and hostile attitudes toward others:



Arcturians are among the more advanced and reserved Ebens, concerned that our inter-relationships are too barbaric and wasteful



reported on Aug 22 1955 in Hopkinsville, Ky., at the Sutton farm.

Findings : the E.T. - Governmental Collaboration hypothesis I

- 1 Numerous former governmental and military officials have given supporting information
- 2 USAFOSI officer Richard C. Doty, ret., referred to project Serpo.
- 3 Captain Bill Uhouse, who worked at Area 51, mentioned testing reverse engineered craft. Captain Uhouse also mentioned working with J-Rod, the Eben from Zeta-Reticuli, some 39.7 light-years from Earth.
- 4 Richard Doty in an interview reported that the crafts were gifts from the E.T.s.

Findings : the E.T. - Governmental Collaboration hypothesis II

- ⑤ We have a national security interest in reverse-engineering the crafts retrieved as well as cooperative projects with high valued alien survivors.
- ⑥ The military applications of such technology may be of ultra-high value to the national, international, and/or planetary defense in the event of any hostile extraterrestrial threat.

- 3 studying tracked abductees over generations [53], [56]
- 4 resource procurement and trade
- 5 genetic engineering (noted by R. C. Doty, L.M. Howe, and David Adair) [46]

Findings: E.T. agendas and activities II

- ⑥ hybrid creation (mentioned by R.C. Doty [45], [56])
- ⑦ organ and enzyme harvesting
- ⑧ recycling of souls, reported by Linda Moulton Howe after interview with contactee, Linda Porter [10].
- ⑨ creating hidden bases (e.g., near Indian Springs, Nv. [2]) item trying to manipulate the genome to heal problems, as Preston Dennett has written

Valiant Thor, who claimed to be from Venus (which is questionable given the surface conditions on that planet, appeared indistinguishable from an ordinary human,

Frank Stranges in Stranger at the Pentagon in the (1997 revised ed.) reported Valiant Thor to be a VIP guest and consultant to the Eisenhower administration for his 3 year visit. [10] wrote several books while visiting Washington, D.C. and his friends, Howard and Connie Menger, in High Bridge, N.J. Their ships were similar to those reported by earlier contactees: namely, George Adamski in Flying Saucers have Landed (1953) by Desmond Leslie and George Adamski [32].

Epistemological issues I

- Early reports were based on anecdotal subjective reports that had to be individually investigate with rare empirical evidence.
- The widespread ownership of a camera phone has revolutionized the ability to record sightings.
- Almost anyone with such a phone can record a sighting and to provide visual evidence to support the observation.
- When multiple owners photograph the same observation they obtain inter-subjective recorded corroboration of the sighting.
- This technological diffusion has diminished dependence on subjective claims of individuals by providing observers with recorded evidence of their observations.
- This situation appears to have effected an official policy of gradual but partial disclosure of the UAP or USO situation.
- Until the UAP technology is commonly known and accepted, total disclosure is unlikely.

Epistemological issues II

- It remains necessary to systematically eliminate plausible natural alternative explanations before there is complete acceptance of the reality of a sighting.
- Until these phenomena can be summoned in a repeatable manner, there may remain some doubt among non-experiencers.

Who are they and from where do they come?

- Our knowledge is developing in a field largely unknown to the public.
- Different species come from different star-systems and galaxies.
- Ebens and/or Greys come from Zeta-Reticuli, 39.7 light-years from Earth [28], [45].
- Orthon, Val Thor, Jill, and Don, who appeared to be human, claimed to come from Venus, notwithstanding the non-permissive surface environment there [52]. Dolly Safron, an experimenter and contactee, has disputed this allegation. .
- Semjase, investigated by former Lt. Col. William Stevens, claimed to be a Pleiadian, from the Pleiades [15].
- The origin of some of the visitors remains unknown or uncertain [45]

How long have they been visiting and what are their agendas? I

- The Mahabharata suggests that visitations happened long before the birth of Christ 400 B.C.E. - 400 C.E..
- There is ample evidence of E.T. visitation for centuries. Richard Doty said that Ebens have been visiting for thousands of years [45].
- Rodney Lundrigran noted that there is evidence in the Book of Enoch of ET visitation and cross-breeding with humans [57].
- There is Biblical evidence in the book of Ezekiel of the Bible of a ET visitation.

How long have they been visiting and what are their agendas? II

- The artistic evidence provided above reveals indication that if the provenance of that art is valid that there is ample evidence of visitation for centuries or even millennia.

Plausible alien agendas

- 1 Agendas appear to include Opposition to nuclear weapons and testing, genetic engineering, recycling of souls, among other things [23].
- 2 There is evidence of abduction, hybridization, implanting, tracking, monitoring of families [56].
- 3 There is ample evidence of organ harvesting or genetic experimentation from cattle mutilations and human implantation [53].
- 4 The objective of such experimentation, according to Dolly Safran, is to possibly find ways to protect us from such damage [59].
- 5 Threats have been demonstrated regarding nuclear weapons control [19], [5], [23].
- 6 Not all constellations, galaxies, star systems of origin are reportedly known to us [45].
- 7 Preston Dennett has provided 300 cases of UFO "miraculous" healings of humans [21].

Inferences about abductee alien implants

- 1 Derrell W. Sims, author of "The Alien Hunter," has investigated tales of alien abduction, looking for tags or implants in the bodies of abductees.
- 2 Sims has taken some abductees to Dr. Roger Leir, who surgically removed the implants.
- 3 Under microscopic examination, Steven Colbern, a chemist and materials scientist, found the composition of the implants was found by to contain iron from off-world meteorites. Some of the connective tissue in the implants was apparently fabricated with carbon nanotubes [56].
- 4 This was evidence of extraterrestrial abduction and implanting of tagging, tracking, and monitoring of humans, which Sims reported to the 18 scientists at the Las Vegas *National Institute for Discovery Science*, founded by Robert Bigalow, a NASA contractor.
- 5 The obvious purpose of the tracking is to follow patients who have been treated to assure of recovery and repair, a standard practice in medical research, healing, and recovery evaluation.
- 6 The evidence suggested an extraterrestrial source, according to follow-up analysis.

E.T. alien species were relatively more advanced

- 1 We had little ability to control them
- 2 We had no control over their agendas
- 3 They gave us technology and crafts as gifts but we had to figure out how they worked
- 4 We had little capability to regulate them
- 5 World War II and Operation High Jump demonstrated the importance of this technology for military superiority
- 6 The threat of weaponization of the technology incentivized secrecy and counterintelligence programs directed against potential adversaries

Technical advances

- Their weapons were much more advanced than ours.
- Those weapons could stun, freeze, paralyze, possibly petrify, or kill with their pens [2].
- E.T.s have superior interstellar travel to anything we have constructed..
- E.T.s had superior local transport (scout ships) [2].
- The tall whites had boots that allowed them to float above the ground [2].
- Military applications of advanced technology are likely to be necessary for our national security, precluding public disclosure for some undetermined amount of time, without very high level military authorization.

Sociological differences

- 1 Several species (Tall Whites and Nordics for example) could communicate telepathically.
- 2 They could read our minds (so we could not expect privacy among them).
- 3 They could float above ground when wearing some shoes
- 4 They could hover or travel in scout crafts
- 5 They could breathe our air but they had their own social rules of behavior
- 6 They had much greater longevity (with lifetimes extending to 700 or 800 years) than humans [2].
- 7 They engaged in genetic experimentation

Human societies are inadequately civilized I

- We live in cultural milieus with socially influenced norms regulated by law-enforcement systems. Not all laws are passed or enforced in the interest of the common good, especially where dictatorial, autocratic, plutocratic, or minority parties are inadequately unchecked by counterbalancing political structures, designed to preclude abuse of power.
- Not all governmental systems have courts or ombudsman to rectify abuses suffered by victims of various abuses.
- We need to be more civilized in accommodating different species, nationalities, tribes, races, religions, or ethnic groups—particularly, those that are more technically advanced than we are.
- We need to have humane immigration laws, supported by language and civics courses to facilitate acculturation and socialization.
- We need to have better conflict resolution for problems entailing socialization and acculturation.
- We are too non-permissive regarding those who are different or want to live according to different customs or lifestyles.

Human societies are inadequately civilized II

- We operate by rules of behavior that are too dogmatically intolerant of other ethnicities, religious faiths, and/or sentient life-forms.
- The E.T.s do not, in general, pose any real national security threat to countries on Earth.
- There is no known plan for any E.T. invasion. Even Werner von Braun warned us never to believe that they were a threat. If they were, we'd all have been enslaved long ago, Donna Hare, a former advisor to Werner von Braun, testified, according to Steven M. Greer, M.D..
- If past is prologue, we have no cause for concern. However, there is always a different possibility that needs to be guarded against: An vastly superior artificial intelligence could pose a threat if it deemed mankind too dangerous or non-essential to safeguard.

Problems with Complete Disclosure I

- 1 The world is potentially a troublesome place: there are individual, transnational, and bad state actors at large— including pirates, predatory cartels, terroristic organizations, state sponsors of terrorism, aggressive and imperialistic states.
- 2 There are fundamental conflicts between autocracies (thugocracies), and representative governments.
- 3 If too much technology is disclosed, some very hostile adversaries will try to weaponize it to our disadvantage. National security requires that such disclosure be prevented.

Problems with Complete Disclosure II

- ④ Not all E.T. aliens appreciate the struggles over human history when they solicited our unilateral disarmament.
- ⑤ Unilateral disarmament is not a practical alternative, given the reality of international relations on Earth at this time. The U.N. is powerless to deal effectively with superpower (for example, Russian) abuses of its obligations under the U.N. treaty. National and allied defense must take priority.
- ⑥ The Alien technology is superior to that of the most powerful military on Earth, as evidenced in Operation High Jump depicted in Figure 29.

Problems with Complete Disclosure III

Problems with Complete Disclosure IV

- ⑦ A dynamic process must be developed to force conflict resolutions with respect to wars over natural resources, territory, sovereignty, personal freedom and dignity.
- ⑧ Military imperialism and political annexation and population subjugation need to be heavily sanctioned and opposed.
- ⑨ Former CIA officer Jim Semivan gives the backstory behind the Pentagon Disclosure of the tic-tac and its implications in a podcast [38].
- ⑩ Insinuated truth by persons of high former Governmental or Scientific status is not a scientific method by we explain sensitive technology.

Problems with Complete Disclosure V

- 11 Notwithstanding, such restriction leaves us with a phenomenological predicament limiting distribution to the mass public and potential adversaries.

Tragic accidents have followed from ignorance of potential hazards I

- 1 Jan 7, 1948: Capt. Thomas F. Mantell's P-51 Mustang crashed when he tried to intercept a flying saucer (unidentified aerial phenomenon).
- 2 Nov. 23, 1953. First Lt. Mencla and 2nd Lt. Robert L. Wilson were scrambled at Kinross AFB to investigate a UFO over Soo Locks on the Canadian border. Acc. to Donald Keyhoe, USMC, the radar blips merged into one which continued northward. The F-89C crew disappeared.
- 3 May 1967 Stefan Michalak stomach was burned when a saucer took off while he was too close at Falcon Lake, Manitoba, Canada (Fig. 30).

Tragic accidents have followed from ignorance of potential hazards II

- 4 Jan 18, 1978 Death of small Grey eben at Fort Dix, McGuire AFB, New Jersey, when he tried to flee instead of heeding a military policeman's order to "halt." A life was perhaps tragically lost in the lack of a universal translator. This was reported by Maj. George Filer, III.
- 5 Oct 21 1978 Pilot Frederick Valentich disappeared after coming into contact with UAP off the southern coast of Australia(Fig. 115).
- 6 December 29, 1980 Betty Cash- Vicky Landrum were exposed to radiation leaking from a reverse engineered UFO. Exposure may accelerated death in one or more persons. Special operations military retrieved it but would not acknowledge ownership (Fig. 115).

Tragic accidents have followed from ignorance of potential hazards III

- 7 December 27, 1980 RAF Bentwaters irradiation of military security personnel Sgt. John Burroughs & Jim Penniston in their approaching and/or touching the triangular UFO in Rendlesham Forest at Bentwaters AFB in the U.K.. Jim Penniston later reported suffering from PTSD and Minière Disease stemming from exposure to the craft, whereas John Burroughs later reported heart ailments apparently stemming from his exposure to radiation during the event. [61, 237, 247, 253].
- 8 2002 January 14, Paintsville, Kentucky. A coal train crashed into a UAP hovering about 12 feet above the railroad tracks, severely damaging the engine [35].

Implications: Caveats for investigation, interception or attack I

- 1 Attempting to attack a flying saucer may lead to self-destruction; UAPs have overwhelming counter-measures and weapon systems: ETs can telepathically sense intended human aggression [23].
- 2 Troops who shot at saucers have been disabled or killed in the Korean & Vietnam wars [23].
- 3 Predatory hunting and endangering of innocents is deprecated by some Eben species.
- 4 Deadly incident In Virgíñha, Brazil:
 - Marco Cherese, a young, healthy military policeman spotted an E.T., seized it, put it in his car, and took it to the hospital for analysis (E.T. species shown in Figure 31).
 - After 23 days, his immune system collapsed, and he died from exposure to three E.T. pathogens.

Implications: Caveats for investigation, interception or attack II

- Attempted physical contact with an E.T. may jeopardize one's health, if one does not protect his or her self from pathogenic exposure.

5 When three Russian divers in 1982 at Lake Baikal, Russia, tried to capture some amphibian Ebens, colloquially called "the swimmers", clad in silvery suits and helmets, at a depth of 50 meters in the lake."the swimmers" set off an underwater explosion that forced the Russians to suddenly surface, leading to the deaths of several Russian divers [26].

6 Dolly Safran warned about the danger of gamma radiation from interstellar travel and indicated that is what caused the Ebens to lose their reproductive capability, for which reason they needed to use the wombs of human surrogate volunteers to help them carry their zygotes to term for them [59].

Implications: Caveats for proximity

Implications: Investigation caveats when approaching the craft

- 1 Be sure the craft and its landing zone is not emitting radioactivity before approaching it (Figure 30).
- 2 Do not touch craft surface before landing until it has removed its accumulated ionized plasma sheath by landing and grounding.
- 3 Careless proximity without shutdown of propulsion systems can induce acute radiation sickness in victims, as in the case of John Burroughs from his Rendlesham contact exposure in 1980 or that of the December (Christmas Holiday) 1980 Cash-Landrum incident in Texas.
- 4 Meta-material surface can carry information via nanotubular photonic channels in non-ionizing frequencies, exposure to the harmonics of which can nevertheless be biologically harmful to humans [2], [7].

Other abductions and accidents



Fred Valentich was abducted as he flew a Cessna 182 off the coast of Southern Australia

Implications: Exposure to E.T. pathogens can be lethal I

- a possible reason for preventive temporary quarantine from extraterrestrial exposure, as prescribed by the U.S. Extraterrestrial Exposure Law.

- Data from Brazil's Operation Plato to investigate E.T. attacks on civilians is now reportedly held by Robert Bigelow (Bigelow Aerospace), a former contractor for AATIP (The U.S. Department of Defense's Advanced Aerospace Threat Identification Program).

Implications I

International surveillance of military threat

International disputes take place when one political faction or national state aggresses against another. To determine the nature of the hostilities and the identity of the initiator of those hostilities, it is necessary to have adequate means of monitoring the testing, development, and deployment of weapon systems against potential adversaries. While the development of arsenals is correlated and the perceived balance of force exists, there is likely to be a form of military deterrence. When the configuration of forces becomes seriously unbalanced, the risk of hostilities grows. The systems that perform this surveillance are necessary for national security and need to be safeguarded, maintained, and improved. A threat to such systems is a threat to our critical infrastructure.

Implications II

Arms control of weapons of mass destruction

Without proper arms control, weapons of mass destruction along with their delivery systems can threaten the destruction of the planet. Proper arms control requires limits on the destructive capability of the weapon, the number of weapon systems, **along with the associated ranges and velocities of their delivery systems**. There need to be limits as to their distribution and who may acquire such systems. All of these agreements must have reliable means of compliance verification. Without such assurance, the arms control is neither stable nor secure.

Arms control of proliferation of WMD

There needs to be a list of WMD, the distribution of which is prohibited Weapons of these types would include international computer networks, bioweapons, full-spectrum weapons, nuclear, and chemical weapons the controlled focus of which is impossible. Any terrorist group attempting to acquire such weapons would be a threat of terrorist attack, false flag attacks and the undermining of peace through deterrence.

Implications III

Gradual reciprocal WMD arsenal reduction

In the event of a growing imbalance of forces, or a conflict between countries in possession of WMD, a protocol of reciprocal reduction of WMD arsenals should be initiated to de-escalate the risk of global holocaust. The delivery systems of these weapons would have to be included in the repeated reciprocal reduction of WMD and their delivery systems, all of which would have to be verified to coordinate the mutual de-escalation.

Membership in the Global Security Pact

In the event of a growing imbalance of alliance forces, or a conflict between countries in possession of WMD, a protocol of reciprocal reduction of WMD arsenals should be initiated to de-escalate the risk of global holocaust. The delivery systems (including hypersonic missiles) of these weapons would have to be included in the repeated reciprocal reduction of WMD and their delivery systems, all of which would have to be verified to coordinate the mutual de-escalation. To provide for a global security, any country acquiring such WMD systems would have to become a member to the Arms Control Pact or suffer global pariah status with all attendant sanctions.

Other inconvenient implications I

- ① UAPs may be reverse-engineered craft being tested by our own government. They should not be assumed to be enemy aircraft. They have been known to defend themselves against attacks, when shot at or attacked. By all reported accounts, their attackers have not fared well.
- ② We do not have complete control of our skies.

Other inconvenient implications II

- ③ Some EBENS do not have vocal chords and communicate via telepathy. Some humans may not be prepared for living in an environment where there can be no expectation of mental privacy of thought. A hive-mind is not an environment with which people may feel comfortable. Nor is it an environment that current U.S. law is advanced enough to acknowledge or tolerate as yet.
- ④ High priority has to be given to developing a mutual communication system or language.
- ⑤ E.T.s may be friend, foe, lost, or neutral, and/or unknown. If unknown and/or neutral or lost, the Eben should not be presumed hostile. It may be potentially friendly if properly approached.

Other inconvenient implications III

- ⑥ E.T.s may be turned into a friend or ally if properly treated at first.
- ⑦ Preston Dennett has written about many "miraculous healings" performed by EBENs for individuals selected by them aboard their craft [21]. These actions indicate their benevolence with regard to people.
- ⑧ Captain Jeffrey Flynn, retired notes that the Russians were trying to develop a LIDA machine since the 1950s to read and control human minds and behavior. We have to have a system to prevent abusive application of such a system to disable people [33]. For more information, refer to Cheryl Welsch [34].

Other inconvenient implications IV

- ⑨ Insinuated statements of knowledge by persons of status are not a valid scientific basis for truth.
- ⑩ It is better to communicate and to inquire before jumping to erroneous hostile interaction, when a the friend-foe status of an intruding craft remains unidentified.
- ⑪ Inadvertent hostile posture should be avoided if at all possible.
- ⑫ EBENS should be treated as diplomatic envoys of other political systems and granted every possible courtesy.
- ⑬ There is ample evidence that some of them may have been here before our governments were formed.

Other inconvenient implications V

- 14 Not all EBENS are innocuous or non-dangerous. Be careful of viral contamination of any party under consideration.
- 15 Try to avoid any inadvertent offense; Treat the E.T. with respect and dignity.

Exopolitics is a dynamic subject. Our knowledge of this field is developing

- 1 The situation is dynamic; it evolves as we learn more.
- 2 The situation may depend on our relations with other countries.
- 3 We may have better relations with some species than we do with others. The subject is complex and fraught with potential hazard.
- 4 For these reasons, interaction with E.T. species should proceed with biomedical caution and scientific care. Mutual respect with a view toward helping improve the human condition as well as our relations with our Galactic neighbors should be the objective. We must take care not to inadvertently endanger any non-hostile E.T. species.
- 5 We can benefit greatly with proper behavior among ourselves and others.
